### **Finance Board Update:**

Anderson stated that the finance board meet twice since the last board meeting and approved all department invoices. The operational budget is currently at 59% of the budget through the first 7-8 months. The Capital budget is over running due do the fire truck purchase and will need to be amended.

Cumings stated in review of the department invoices he was pleased to see that the department was spending expenditures on training and seminars. He stated it's a good idea to keep the department trained and will help the department employees by knowing we are taking the time and money to keep the department current.

### **Old Business:**

Lease agreement. Chief Olney reviewed the lease agreement between the Fire Department and PNC Equipment Finance LLC for the purchase of a Pierce Saber Pumper. Olney stated he contacted the fire department's attorney (James Scales) for an opinion on the lease of the vehicle and to review the contracts. The Departments attorney and the attorney for PNC were in contact with each other to review the contracts and make corrections as needed. The lease presented to the fire board has been reviewed and approved by our department's attorney. It was the consensus of the fire board to have Chief Olney sign the agreement as the fire chief, Dale Bergman sign as the fire board chairperson and Bill Goodfellow sign as the secretary for the fire board.

## **COVID Expenses to Township:**

Chief Olney presented to the board a list of expense items which could be covered under the CARES ACT through the Township. The chief was asked to consider adding in turn out gear and laptops if they are an approved item. The board asked the Chief to have the list available and presented to the township at the December meeting. Bergman will check on the deadline for filing the expenditure with the county.

## **Budget submitted to the Village:**

Chief Olney stated he presented the fire department's 2021-2022 budget to the Village at their November 9th meeting. The Chief stated that there we few questions on the budget and village will present his request at the annual village budget meeting.

Chief's Report: Chief Olney presented the Chief's report. (see attached). There were 756 calls YTD. The Chief stated there were 5 fire calls and 6 accidents last month. The Chief stated that there are (2) incidents where the department will be seeking cost recovery.

Chief Olney also stated that are (3) fire fighters in quarantine because they may have been exposed.

Chief's Annual Review: (was not discussed due to Zoom timed out and ended.)

The fire board is required to provide the Chief with his annual performance review per the contract. I'll attach last year years review and the format required for this year. The information is due back to me by no later than December 14<sup>th</sup> so I can summarize and compile into one document.


